CSS Venue Automation System for Access & Lighting

from \$6,000* inc. GST

- A unique 4-digit PIN is provided on booking confirmation to grant court access and also activate court lighting, if lighting is integrated. This PIN will remain the same for the user each time they book at the same venue.
- PINs will be active 15 minutes before the booking start-time and will expire 15 minutes after the booking end-time. Lights will also turn on (once the sunset switch deems there is insufficient daylight) and off at these times.
- Two 6-digit site PINs that grant 24/7 access are also available for use outside of court bookings (e.g. maintenance to courts, council access or meetings).
- Ability to make bookings under a specific category that keeps thegate(s) in an unlocked state for the duration of the booking (e.g. for coaching or competitions).
- Ability to integrate with additional electronic access requirements such as clubhouse doors, toilets or security surveillance that also work in conjunction with bookings.
- Ongoing service fee of \$400 ex. GST, invoiced annually direct from supplier.
- A 12 month warranty on hardware and labour from the date of system installation. After 12 months, an extended 48-month warranty on all Protege parts (i.e. not all components of the solution and labour fees excluded).

Need to know information

- * Estimated cost for a venue requiring one keypad access to control up to eight lit courts. Costs do not include shipping costs, installation of the system or any works associated to integrate court lighting with the system by the venue's electrical contractor.
- "Pre-installation works" may need to be carried out to prepare the venue for installation, these requirements will vary at each venue and are dependent on existing infrastructure and proposed location of equipment. Costs typically range from \$500 for a venue with minimal requirements to over\$3,000 for a venue with extensive requirements.
- Once a quote has been received from Complete Security Solutions outlining pre-installation works, venues are strongly encouraged to source quotes for completion of these works to understand the full budget associated to the installation of this solution.

Igloohome Padlock for access

\$385 inc. GST per lock

- A 9-digit PIN is provided on booking confirmation that will grant court access for each booking.
- PINs are active at least 30 minutes before the booking start time, and expire at least 2 hours after the booking end time.
- There is a 12-month warranty on the lock that starts when the lock is paired with the Igloohome App. Full replacement will occur for any issues under this warranty period.
- To connect the lock with the ClubSpark software, a fee of USD\$2per lock is deducted monthly from a debit/credit card set up with Iglooconnect.
- Manual PINs can be generated via the Igloohome App or access can be granted via Bluetooth. These methods of access bypass the requirement for making a booking online with ClubSpark.
- Lock activity status, including PIN entries can be viewed via the Igloohome App. For up-to-date activity status, the lock must be synced with the App.

Need to know information

- The venue gate may need to be modified to suit the padlock shackle.
- > Venues should instruct players on how to place the lock once access is granted and when exiting the facility to avoid courts being left unlocked.
- > Battery life is up to 12 months. The battery is rechargeable via USB-C cable and will reach 100% in 1 hour.
- To secure the lock to the gate or fencing, venues will need to purchase stainless steel cable ties or a suitable alternative, which can be purchased from Bunnings or other hardware store for under \$10.

BCS Lighting for lighting

rom **\$3,850** inc. GST

- A 8-digit pin is provided on booking confirmation to activate court lighting. The PIN will be a new 8-digit combination for each booking.
- PINs will be instantaneously active from the time of booking, however lights will only activate if the light turn on time set by the venue has been reached.
- There are two options available dependent on the number of relays required for the venue; 4-relay unit costs \$3,850 incl. GST and a 8-relay unit costs \$4,213 incl. GST.
- This solution is supply-only, and installation costs are not included in this price. Venues must source a qualified electrician to install.
- Ongoing service fee of \$99 ex. GST, invoiced annually direct from supplier.
- 12 month warranty from the date equipment is supplied.

Need to know information

- Modifications to existing court lighting infrastructure oradditional equipment may be required to ensure compatibility for this solution, in addition to installation costs.
- > Venues can combine this lighting solution with the Igloohomelock for a complete access and lighting integrated solution.

Note: both solutions would still run separately (i.e. two PINs will beissued per booking).

Non-affiliated venues may be required to pay a fee to the Member Association (MA) for the use of the ClubSpark software with the integrated hardware solution.

This fee will be determined by and payable to the MA on an annual basis. In addition, non-affiliated venues should have Public Liability Insurance to cover players.
