## CARDIO TENNIS PROGRAM VOLUNTEER DELIVERED TERMS AND CONDITIONS (TERMS AND CONDITIONS)

#### 1. Introduction

- (a) Tennis Australia Limited (**TA**) has established a program with the objective of increasing the opportunities for people to play tennis by volunteers (**Cardio Tennis Program Volunteer Delivered**).
  - (a) The Cardio Tennis Program Volunteer Delivered is open to Affiliated Tennis Venues who do not have a qualified coach (**Venue**). The Cardio Tennis Volunteer Program involves a volunteer deliverer who is not a tennis coach undertaking the Cardio Tennis Volunteer Training offered by TA and organising the delivery of Cardio Tennis at the Venue (**Cardio Tennis Volunteer Deliverer**). It is envisaged that the Cardio Tennis Volunteer Deliverer may be assisted by volunteers who are not tennis coaches to help run the Cardio Tennis Program (**Cardio Tennis Volunteer Assistants**).

#### 2. TA's Role

#### (a) Application Process

- (i) TA will review applications to participate in the Cardio Tennis Program Volunteer Delivered and may accept or reject applications in its discretion.
- (ii) TA may approve applications subject to certain conditions.

## (b) Benefits provided to the Venue by TA

If an application to participate in the Cardio Tennis Program Volunteer Delivered is approved, while the Venue is part of the Cardio Tennis Program Volunteer Delivered and complying with its obligations, TA will provide the Venue with the following benefits:

- (i) recognition of the Venue as an official Cardio Tennis venue on the relevant TA website;
- (ii) a Cardio Tennis Equipment and Merchandise pack;
- (iii) free participation for the Cardio Tennis Volunteer Deliverer at yearly professional development, either online or face-to-face
- (iv) ability to purchase discounted tennis equipment;
- (v) Cardio Tennis branding suite, including logo and images; and
- (vi) opportunity for a participant to take part in an experience at the Australian Open (AO) and Summer Series events or a similar VIP tennis experience each year.
- (vii) Any other benefits associated with the Cardio Tennis Volunteer Program



## 3. Venue's Responsibilities

#### (a) Overview

The Venue agrees to:

- (i) continue its affiliation with its respective State/Territory Member Association;
- ensure that all volunteers and other members involved in the running of the Cardio Tennis
   Program Volunteer Delivered at the Venue comply with these Terms and Conditions;
- (iii) have the Venue committee's support of the Cardio Tennis Program;
- (iv) conduct the Cardio Tennis Program at least one time (1 x 4–6-week program) annually;
- (v) comply with all applicable TA by-laws, policies, rules, and procedures (each as amended from time to time), including but not limited to its Member Protection Policy;
- (vi) nominate a Cardio Tennis Volunteer Deliverer;
- (vii) ensure the Cardio Tennis Volunteer Deliverer provides a current State/Territory Working with Children Check (WWCC) or State/Territory equivalent, a National Police Check (NPC), and signed Member Protection Declaration (MPD) to TA (via MyTennis or screening@tennis.com.au) prior to commencement of Cardio Tennis Program. The State/Territory Working with Children Check requirements vary around Australia and can be found at tennis.com.au/coaches/membership/policies.
- (viii) To ensure any Cardio Tennis Program assistants have gone through the screening processes set out in section 9 of the Member Protection Policy and provided the Cardio Tennis Volunteer Deliverer with:
  - i. a signed Member Protection Declaration and WWCC (mandatory); and
  - ii. a NPC (if held by the Volunteer)
- (ix) comply with all specific Cardio Tennis Program policies, guidelines and policies issued by TA from time to time, including any policies, guidelines and procedures issued in relation to the Cardio Tennis Program;
- (x) have the Cardio Tennis Volunteer Deliverer and the Cardio Tennis Volunteer Assistants undertake training to conduct Cardio Tennis (either face-to-face or by reading the delivery guide and watching video footage);



- (xi) provide TA with information relating to the Program if and when requested by TA; and
- (xii) update TA on the status of the Cardio Tennis Volunteer Deliverer and Assistants, as requested by TA. Any inactive Cardio Tennis Volunteer Deliverer and Assistants will no longer have access to the benefits provided by TA.

## 4. A Safer Game Plan Module

- (a) The Venue acknowledges that TA will require each Volunteer to complete the Safer Game Plan Module to be able to participate in the Cardio Tennis Program Volunteer Delivered.
- (b) To be accepted as a Cardio Tennis Volunteer Deliverer, each Volunteer must complete the Safer Game Plan module prior to commencement of the Cardio Tennis Volunteer Program.
- (c) Equipment and ongoing program support for the Cardio Tennis Program Volunteer Delivered will not be provided without completion of the Safer Game Plan Module.
- (d) TA may prevent the appointment of a Cardio Tennis Volunteer Deliverer if they do not complete or refuse to complete the Safer Game Plan Module.
- (e) Where requested, the Venue agrees to assist TA in conducting the Safer Game Plan Module.

## 5. Education Module

- (a) The Venue acknowledges that TA will require each Volunteer to complete the Education Module to be able to participate in the Cardio Tennis Volunteer Program.
- (b) The Education module must be completed within 12 months of registering.
- (c) TA may prevent the appointment of a Cardio Tennis Volunteer Deliverer, if they do not complete or refuse to complete the Education module within 12 months.
- (d) TA may withhold supply of updated equipment packs and access to online content if the Education Module is not completed within 12 months.
- (e) Where requested, the Venue agrees to assist TA in conducting the Education Module.

## 6. Licence Fees

(a) TA grants to the Venue a licence to use and access the Cardio Tennis branding, content, online



advertisement, education and ongoing support (**Licence**). In order to obtain the Licence, New Venues are required to pay a Licence Fee. A New Venue is one that has never delivered Cardio Tennis before. The Venue acknowledges that if they do not renew the Program within 2 years, they will be deemed as a New Venue (**New Venue**).

- (b) The Licence Fee is \$130 AUD for the Cardio Tennis Program.
- (c) The ongoing renewal cost of the Program is \$0 for Venues who complete the mandatory online Education Modules
- (d) The Venue must provide TA with the completed modules from the Cardio Tennis Program to determine that they are eligible to facilitate the Cardio Tennis Program
- (e) The Venue acknowledges that they will be required to pay the Licence Fee of \$130 if they have not renewed their membership within 2 years.

## 7. Logo and Branding

- (a) As part of the Licence, the Venue is granted access to the Program's branding in the form provided by TA in the branding suite (or any replacement logo notified by TA to the Venue from time to time) to use on the Venue's website, in the Venue's newsletters, and subject to the written consent of TA, in other approved marketing and promotional material for the Cardio Tennis Program. Venue must only display, use or refer to the Cardio Tennis Program logo as approved by TA and in good faith so as to enhance and promote the goodwill and reputation of TA and the Cardio Tennis Program.
- (b) It is imperative that TA protects its intellectual property and ensures consistent use of its brand. When making reference to the Cardio Tennis Program, the Venue must use the full Program name (as notified by TA to the Venue from time to time) in all promotional documents.

## 8. Assumption of Risk and Insurance

The Venue agrees to carry and accept all risks in the running of the Cardio Tennis Volunteer Program.

The Venue must maintain professional indemnity insurance for an amount of \$10 million per claim and public liability insurance for an amount of \$20m per occurrence during the Term to the satisfaction of TA, and if requested, provide certificates of currency to TA. The Venue is responsible for ensuring that any teachers, coaches or other volunteers that are assisting with the Cardio Tennis Program are covered by the Venue's insurance (or carry their own insurance).



## (a) Confidentiality

The Venue agrees not to disclose any confidential details of the Cardio Tennis Program or Cardio Tennis to any third party, except with TA's prior written approval.

## (b) Privacy Statement

The Venue consents to TA collecting, storing, using and disclosing personal information in respect of individuals involved in the Cardio Tennis Program accordance with TA's privacy policy. A copy of TA's privacy policy can be found at http://www.tennis.com.au/privacy.

## (c) Consent to use of Image

In consideration of the Venue's participation in the Cardio Tennis Program, the Venue consents, and agrees to procure the consent of all participants in the Cardio Tennis Program, to TA taking, retaining and reproducing images or likeness' obtained during the participants' participation in the Cardio Tennis Program at the Venue in photographs, electronic images, sound recordings and video footage and to use such images or likeness' for the purposes of any TA promotional, advertising, research or marketing materials (including for the promotion of the Cardio Tennis Program).

## 9. Cardio Tennis Volunteer Deliverer's Responsibilities

## (a) Screening

In conjunction with the Venue, the Cardio Tennis Volunteer Deliverer must ensure any Cardio Tennis Program Volunteer Assistants have provided a Member Protection Declaration, WWCC and NPC (as required by 3(a)(viii)). It is the responsibility of the Cardio Volunteer Deliverer to collect and provide this documentation to the Venue for the Venue's records. Such documentation must also be provided to TA on request.

## (b) Confidentiality and Logo Usage

The Cardio Tennis Volunteer Deliverer agrees not to:

(i) use the Cardio Tennis intellectual property or logos; or Cardio Tennis Program Terms and Conditions Volunteer Delivered



(ii) disclose any confidential details of the Cardio Tennis Program to any third party except the volunteers, for any purpose other than delivering the Cardio Tennis Program at the Venue.

## (c) Privacy Statement

The Cardio Tennis Volunteer Deliverer consents to TA collecting, storing, using and disclosing their personal information in accordance with TA's privacy policy. A copy of TA's privacy policy can be found at <a href="http://www.tennis.com.au/privacy">http://www.tennis.com.au/privacy</a>. The Cardio Tennis Volunteer Deliverer understands that their name and contact details may be publicly available so people can conduct them in respect of the Cardio Tennis Program.

## (d) Consent to use of Image

In consideration of the Volunteer Deliverer's participation in a Cardio Tennis Program, the Cardio Tennis Volunteer Deliverer consents and agrees to assist the Venue to procure the consent of all participants in the Cardio Tennis Program, to TA taking, retaining and reproducing images or likeness' obtained during the participants' participation in the Cardio Tennis Program at the Venue in photographs, electronic images, sound recordings and video footage and to use such images or likeness' for the purposes of any TA promotional, advertising, research or marketing materials (including for the promotion of the Cardio Tennis Program). The Cardio Tennis Volunteer Deliverer consents to TA, its Member Associations and its government and commercial partners, recording and photographing in the Cardio Tennis Program. Any such photographs, electronic images, sound recordings or video footage may be used by TA, its Member Associations and its government and commercial partners, in resources and reports, or promotional, advertising or marketing materials, without any further notice or payment.

#### 10. Term and Termination

- (a) These Terms and Conditions commence on the date that the application to participate in the Cardio Tennis Program is submitted to TA and continues until it is terminated in accordance with these Terms and Conditions.
- (b) TA may terminate the arrangement described in these Terms and Conditions immediately if:



- (i) the Venue breaches any of its obligations during the Term and if the breach is remediable, having received written notice of the breach has not remedied the breach within 14 days; or
- (ii) the Venue engages in conduct which has brought, brings or would have the tendency to bring TA or the sport of tennis into disrepute or, which is or would have the tendency to be inconsistent with, contrary to or prejudicial to the best interests, image or values of TA or its sponsors.
- (c) TA may cancel the Cardio Tennis Program at any time and if that occurs, the arrangements described in these Terms and Conditions will immediately come to an end.
- (d) TA may cancel the Venue's right or to participate in the Cardio Tennis Program at any time by notifying the Venue.
- (e) TA may cancel a Cardio Tennis Volunteer Deliverer's right to organise the Cardio Tennis Program at any time. In such circumstances, the arrangements described in these Terms and Conditions will come to an end unless TA and the Venue agree on another Cardio Tennis Volunteer Deliverer to fill the vacancy.
- (f) TA may stipulate that a particular person or persons is not to be involved in the Cardio Tennis Program at any time. In such circumstances, the Venue and the Cardio Volunteer Deliverer must ensure that person is not involved. If TA remains uncomfortable about the arrangements, TA may end the arrangements described in these Terms and Conditions.
- (g) If the Venue no longer wishes to participate in the Cardio Tennis Program, it can terminate the arrangements described in these Terms and Conditions by providing TA with 30 days written notice.
- (h) If the Cardio Tennis Volunteer Deliverer no longer wishes to co-ordinate the Cardio Tennis Program, he or she can end the arrangements described in these Terms and Conditions by providing TA and the Venue with 30 days prior written notice.

If the arrangements described in these Terms and Conditions come to an end for any reason or the Venue discontinues from the Cardio Tennis Program at any stage for any reason, the Venue must not make any further public representation(s) as to its continued involvement with the Cardio Tennis Program. TA may request that the Venue return specific promotional items to it (e.g. banners, posters and signs) and the Venue must comply with any such requests immediately. If the Venue fails to comply with such request, TA reserves the right to collect and remove promotional items relating to the Cardio Tennis Program.

The Hot Shots Tennis Program Volunteer involves a volunteer deliverer who is not a tennis coach undertaking the Hot Shots Tennis Volunteer Training offered by TA and organising the delivery of Hot Shots Tennis at the Venue (Hot Shots Tennis Volunteer Deliverer). It is envisaged that the Hot Shots Tennis Volunteer Deliverer may be assisted by volunteer parents or guardians of participating children who are not tennis coaches to help run the Hot Shots Tennis Program (Hot Shots Tennis Volunteer Assistants).

#### 2. TA's Role

### (a) Application Process

- (i) TA will review applications to participate in the Hot Shots Tennis Program and may accept or reject applications in its discretion.
- (ii) TA may approve applications subject to certain conditions.

## (b) Benefits provided to the Venue by TA

If an application to participate in the Hot Shots Tennis Program is approved, while the Venue is part of the Hot Shots Tennis Program and complying with its obligations, TA will provide the Venue with the following benefits:

- (i) recognition of the Venue as an official Hot Shots Tennis venue on the relevant TA website;
- (ii) a Hot Shots Tennis equipment and merchandise pack;
- (iii) free participation for the Hot Shots Tennis Volunteer Deliverer and Hot Shots Tennis Volunteer Assistant at yearly professional development either online or face to face
- (iv) access to Hot Shots Tennis participant benefits for each child who registers on the

- (v) ability to purchase discounted tennis equipment;

- (vii) opportunity for a participant to take part in a "Kids on Court" experience at the Australian Open (AO) and Summer Series events or similar VIP tennis experience each year.



(viii) Any other benefits associated with the Hot Shots Tennis Volunteer Program

## 3. Venue's Responsibilities

#### (a) Overview

The Venue agrees to:

- (i) continue its affiliation with its respective State/Territory Member Association;
- (iii) ensure that all volunteers and other members involved in the running of the Hot Shots Tennis Program at the Venue comply with these Terms and Conditions;

  - (b) a NPC (if held by the Volunteer)

- (xiii) update TA on the status of the Hot Shots Tennis Volunteer Deliverer and Assistants, as requested by TA. Any inactive Hot Shots Tennis Volunteer Deliverer and Assistant will no longer have access to the benefits provided by TA.

#### 4. A Safer Game Plan Module

- (a) The Venue acknowledges that TA will require each Volunteer to complete the Safer Game Plan Module to be able to participate in the Hot Shots Tennis Volunteer Delivered Program.
- (b) To be accepted as a Hot Shots Tennis Volunteer Deliverer, each Volunteer must complete the Safer Game Plan module prior to commencement of the Hot Shots Tennis Volunteer Program.
- (c) Equipment and ongoing program support for the Hot Shots Tennis Program Volunteer Delivered will not be provided without completion of the Safer Game Plan Module.

- (d) TA may withhold supply of updated equipment packs and access to online content if the Education Module is not completed within 12 months; and
- (e) Where requested, the Venue agrees to assist TA in conducting the Education Module.

#### 6. Licence Fees

(a) TA grants to the Venue a licence to use and access the Hot Shots Tennis branding, content,



online advertisement, education and ongoing support (**Licence**). In order to obtain the Licence, New Venues are required to pay a Licence Fee. A New Venue is one that has never delivered Hot Shots before or has not been a registered delivering Venue in over two years. The Venue acknowledges that if they do not renew the Program within 2 years, they will be deemed as a New Venue (**New Venue**).

- (b) As of 1 July 2025, Venues that have already been delivering the Hot Shots Tennis Program, the Venues are not required to pay the Licence Fee if they have completed the mandatory online Education Module and the Safer Game Plan Module.
- (c) The Licence Fee is \$130 AUD for the Hot Shots Tennis Program.
- (d) The ongoing renewal cost of the Program is \$0 for Venues who complete the mandatory online Education Modules
- (e) The Venue must provide TA with the completed modules from the Hot Shots Tennis Volunteers to determine that they are eligible to facilitate the Hot Shots Tennis Program
- (f) The Venue acknowledges that they will be required to pay the Licence Fee of \$130 if they have not renewed their membership within 2 years.

## 7. Logo and Branding

- (a) As part of the Licence, the Venue is granted access to the Program's branding in the form provided by TA in the branding suite (or any replacement logo notified by TA to the Venue from time to time) to use on the Venue's website, in the Venue's newsletters, and subject to the written consent of TA, in other approved marketing and promotional material for the Hot Shots Tennis Program. - (c) TA may cancel the Hot Shots Tennis Program at any time and if that occurs, the arrangements described in these Terms and Conditions will immediately come to an end.
- (d) TA may cancel the Venue's right or to participate in the Hot Shots Tennis Program at any time by notifying the Venue.
- (e) TA may cancel a Hot Shots Tennis Volunteer Deliverer's right to organise the Hot Shots Tennis Program at any time. In such circumstances the arrangements described in these Terms and Conditions will come to an end unless TA and the Venue agree on another Hot Shots Tennis Volunteer Deliverer to fill the vacancy.
- (f) TA may stipulate that a particular person or persons is not to be involved in the Hot Shots Tennis

  Program at any time. In such circumstances the Venue and the Hot Shots Tennis Volunteer Deliverer

  must ensure that person is not involved. If TA remains uncomfortable about the arrangements, TA may

  end the arrangements described in these Terms and Conditions.
- (g) If the Venue no longer wishes to participate in the Hot Shots Tennis Program, it can terminate the arrangements described in these Terms and Conditions by providing TA with 30 days written notice.
- (h) If the Hot Shots Tennis Volunteer Deliverer no longer wishes to facilitate the Hot Shots Tennis Program, he or she can end the arrangements described in these Terms and Conditions by providing TA and the Venue with 30 days prior written notice.

If the arrangements described in these Terms and Conditions come to an end for any reason or the Venue discontinues from the Hot Shots Tennis Program at any stage for any reason, the Venue must not make any further public representation(s) as to its continued involvement with the Hot Shots Tennis Program. TA may request that the Venue return specific promotional items to it (e.g. banners, posters and signs) and the Venue must comply with any such requests immediately. If the Venue fails to comply with such request, TA reserves the right to collect and remove promotional items relating to the Hot Shots Tennis Program.
