Message from the Chair and Executive Director

The 2023–24 period has been one of growth, impact, and deepened community engagement for the Australian Tennis Foundation (ATF). Through our programs, partnerships, and advocacy, we have continued to break down barriers to participation, ensuring that more than 28,000 children and young people facing adversity have had the opportunity to experience the benefits of tennis.

Since 2020, the ATF has provided more than 74,000 participation opportunities to children and families experiencing hardship, reinforcing our commitment to using tennis as a vehicle for belonging, resilience, and wellbeing. By working closely with Tennis Australia, government agencies, and like-minded community organisations, we have expanded our reach, delivering targeted programs in communities where access to sport is often limited.

We remain focused on increasing access to tennis through:

- Community-led initiatives that create sustainable pathways for participation.
- Strategic investment in regional and remote communities to ensure long-term engagement.
- Partnerships with national and grassroots organisations to amplify our impact and deliver programs where they are most needed.

In a challenging economic and social climate, access to sport is becoming increasingly difficult for many families. The ATF continues to play a critical role in removing financial and structural barriers, ensuring that tennis remains an inclusive and accessible sport for all.

This year, we strengthened our focus on key impact areas, including:

 Disaster Recovery and Community Resilience – Expanding our Rally As One initiative, delivering free tennis programs and community events to more than 2,600 children and families in flood and bushfireaffected communities

- Children and Families Facing Hardship - Scaling the Brighter Days program to provide more than 850 children experiencing serious illness or financial stress with a day of respite, connection, and joy through tennis.
- Pathways for Diverse
 Communities Supporting
 more than 3,700 young people
 from First Nations and low
 socio-economic backgrounds
 to access structured tennis
 programs, scholarships, and
 essential equipment.

As the official charity of Tennis
Australia and the Australian Open,
ATF continues to leverage the
Summer of Tennis for awareness and
fundraising. Our fundraising efforts
this year, including charity matches,
corporate engagement, and donor
initiatives, have strengthened
the financial sustainability of our
programs, ensuring that we can
continue to scale our impact.

Moving forward, we will focus on:

- Enhancing our strategic partnerships to deepen our reach and effectiveness.
- Diversifying our funding base to support long-term program sustainability.
- Partnering with Tennis
 Australia, Member Associations
 and likeminded charities to
 extend reach and impact.

On behalf of the ATF, we would like to extend our sincere gratitude to Tennis Australia, our partners, donors, and the broader tennis community for their unwavering support. 



Rally as One

Supporting communities impacted by natural disasters

Northern NSW Roadshow

In October 2023, Tennis NSW hosted a week of tennis activities for communities impacted by flood and bushfire, launched by a community activation at Westport Park, Port Macquarie. With the support of Port Macquarie/ Hastings Council over 450 locals enjoyed the festival atmosphere and were able to pick up a racquet to have a hit with family and friends.

Following the community activation a series of ongoing, free tennis activities were offered at eight surrounding tennis clubs,

providing great opportunities for new friendships to flourish and interest in the game to be converted into regular activity.

NSW Country West Tour

In partnership with Tennis NSW, Rally4Ever and local coach Helen Magill, the ATF hit the road to visit regional and remote communities of Western NSW, using tennis as a vehicle for generating community connection and promoting mental wellbeing.

In a first for the region, a community coaching course was

delivered at Condobolin Tennis Club, training 13 new coaches from Condobolin and surrounding communities, eight of whom were female. This was followed by 24 tennis sessions delivered in six primary schools across Condobolin, Lake Cargelligo and Hilston. In all of these towns, following the activation in local schools, a free community event was hosted at the local courts, with music, food, fun and tennis for the whole family.

Each of the clubs received a fully stocked equipment pack for the newly trained coaches to continue providing opportunities for kids and families to play well into the future.

Over 470 kids were engaged with tennis through school visits and 250 kids and families joined in the five community events hosted.

These locally driven events connected over 440 kids and families, providing opportunities for social and community connection at local tennis clubs. Brighter Days

Using tennis to provide respite for kids and families facing challenging times

Brighter Days events bring likeminded charities to tennis centres nationwide to provide children and families a fun day of respite from their challenging life circumstances. This year, six Brighter Days events were held in State Tennis Centres in Brisbane,

Sydney and Melbourne between May and October 2024.

The Brighter Days program also extends to the AO and Summer of Tennis and this year ATF offered 580 tickets to families from the following charities to share a fun day together and enjoy all the events have to offer:

For the first time at AO24, the ATF was able to invite three lucky participants from the Brighter Days program to perform the Coin Toss in the Opening Week Charity Matches. Families were treated to an exclusive behind the scenes experience before the Coin Toss kids met some of the biggest names in Tennis at the net on Rod Laver Arena. ATF is immensely grateful to Tennis Australia and the Australian Open for the opportunity to provide this unique opportunity to families who have faced some immense challenges in the past year.

Partnership Projects

Reaching more kids by collaborating with other like minded organisations

Low Socio-economic Communities

In partnership with Youth of Tomorrow, Tennis NSW and Tennis Queensland, 1400 primary school students from low socio-economic public schools in Sydney and Brisbane came together across four unforgettable days of tennis immersion. Events were held at the Queensland Tennis Centre in Brisbane and Olympic Park, Sydney and included introductory tennis activities and back of house venue tours. Many of the students had never been to the venues or played tennis before. Following the gala tennis days, the ATF provided each participating school access to funding for after school tennis programs led by qualified coaches to ensure kids had the opportunity to continue to play.

New Arrivals

The ATF has partnered with Reclink Australia in Western Sydney to introduce tennis to children and young people from diverse cultural backgrounds who are new arrivals to Australia. Many of the participants have fled their home country under grave circumstances. Through this social tennis program, they are building friendships and language skills as they integrate into Australian communities. The partnership will expand into Victoria and Queensland in 2025.

First Nations

Australian Tennis Foundation partnered with Tennis Australia, Stars Foundation and Tennis Northern Territory to deliver 30 Ready2Rally sessions to First Nations girls in eight school-based Stars programs in the Northern Territory. 110 First Nations girls were introduced to tennis through Ready2Rally, an innovative tennis program designed specifically for teenage girls.

All sessions included food and time for social connection at the end of the tennis activity, providing girls the opportunity to provide feedback and cocreate future sessions. Equipment kits were provided to enable ongoing opportunities to play and Stars Foundation mentors from each school group were active participants, building confidence and skills to deliver activities independently.

96 per cent of girls attended multiple sessions and 100 per cent would participate again.

After incredibly positive feedback from all involved, the program will expand to Western Australia and continue in the Northern Territory in 2025.

Kids Tennis

Kids Tennis Program offers grants to schools and clubs, enabling them to provide free before and after school tennis sessions for disadvantaged children

This exciting initiative is all about boosting confidence by celebrating positive behaviors, creating a safe and inclusive environment for kids to learn new skills and foster meaningful social connections. Kids Tennis

Program is a proud legacy of the the Kids Tennis Foundation. Since 2020 the program has provided over 60,000 opportunities to play for kids who otherwise may not have the opportunity to pick up a racquet.

Subsidies and Scholarships

Reducing financial barriers to play for young people

Opportunity Knocks Subsidy Program

The Opportunity Knocks Subsidy Program helps young people aged 5-17 facing financial hardship continue their tennis journey. It offers subsidised coaching and support with club membership or competition fees. The program aims to:

- Reduce financial barriers to sports participation
- Use tennis to build resilience, self-worth and a sense of belonging
- Provide access to success and social connections through tennis.

D'Arcy Slater Foundation Grant

In partnership with Tennis West, with funding generously donated by the D'Arcy Slater Foundation, the SunSmart Schools Tennis Classic and the D'Arcy Slater and Women in Tennis Foundation Cup were held in Western Australia.

The 2024 SunSmart Schools
Tennis Classic regional calendar
comprised nine inter-school primary
and secondary school events across
five zones, including the Great
Southern, Upper Great Southern,
Eastern Districts, Central Districts
and the South-West. 449 students
from 35 country schools, entering 96
teams, competed for the Academy
Plate, Herbert Edwards Cup and
Slazenger Cup Titles.

The 2024 D'Arcy Slater and Women in Tennis (WIT) Foundation Cup were hosted in Bunbury for both the team and individual events, drawing a record number of 147 entries split almost 50/50 between the two competitions. Players came from as far south as Albany, north as Broome and as far east as Esperance and Merredin for four days of competition.

Congratulations to Denby Sharpe, Cameron Cockburn, Tea Zizek and Alifaye Gidgup for being the inaugural recipients of the D'Arcy Slater Foundation scholarship to support their ongoing tennis participation.

ATF Lottery

In its third year, the ATF Lottery continues to be a successful fundraising campaign over the Summer of Tennis. Featuring an expanded prize offering for 2024, over 10,500 tickets were sold (80 per cent of tickets available), raising over \$230,000.

This year saw three lucky winners take home some amazing prizes.


Retail lines



3. Members' Funds

The Foundation is a company limited by guarantee. The liability of members is limited to \$20 in the event of wind up. The number of members as at 30 September 2024 was 1 (2023: 1)

4. Principal Activities

The principal activities of the Foundation are to deliver programs for the relief of poverty, misfortune or helplessness in children and young people between 5 and 24 years.

5. Results and Review of Operations

The operations of the Foundation for the year resulted in a \$179,806 surplus of income over expenditure (2023: \$99,047 deficit).

6. Foundation Objectives

Short to medium objectives

- 1. Improved access and equity to engagement with tennis for young people through:
 - a. expansion of programs
 - b. development of new program partnerships to service key target groups
- 2. Establish revenue partnership with the AO to create sustainable fundraising outcomes.

Long-term objectives

 Develop partnerships with government and like-minded Foundations and Organisations to expand the breadth and depth of activity

7. Likely Developments

The Directors do not anticipate any major changes in the basis of operations. A similar rate of growth in activity and participation is predicted for the coming financial year and the Foundation will continue to operate on the basis of a going concern..

8. Environmental Regulation

The Foundation's operations are not subject to significant environmental regulations under both Commonwealth and State legislation.

9. Lead Auditor's Independence Declaration

The Lead Auditor's Independence Declaration is set out on page 3 and forms part of the Directors' Report for the period ended 30 September 2024.

10. Indemnification of Officers

The Foundation has agreed to indemnify the current and former directors and senior officers against all liabilities to another person (other than the Foundation or a related body corporate) that may arise from their position in the Foundation, except where the liability arises out of conduct involving a lack of good faith. The agreement stipulates that the Foundation will meet the full amount of any such liabilities, including legal fees, costs and expenses.

Since the end of the previous financial year, the Foundation has not indemnified or made a relevant agreement for indemnifying against a liability any person who is or has been an auditor of the Foundation.

11. Events Subsequent to Balance Date

There has not arisen, in the interval between the end of the financial year and the date of this report, any item, transaction or event of a material and unusual nature likely, in the opinion of the Directors of the Foundation, to affect significantly the operations of the Foundation, the results of those operations, or the state of affairs of the Foundation in future financial years.

Notes to the Financial Statements

for the Year ended 30 September 2024

1. Reporting entity

The Australian Tennis Foundation (the "Foundation") is a company limited by guarantee and is domiciled in Australia. The address of the Foundation's registered office is at Olympic Boulevard, Melbourne, Victoria.

The Foundation was registered as a company under the Corporations Act 2001 on 17 August 2009 and was registered as a charity with the Australian Charities and Not-for-profits Commission on 1 January 2020.

The Foundation is a not-for-profit entity.

2. Basis of preparation

a. Basis of accounting

In the opinion of the Directors, the Foundation is not publicly accountable. The financial statements are general purpose financial statements which have been prepared in accordance with Australian Accounting Standards - Simplified Disclosure Requirements adopted by the Australian Accounting Standards Board (AASB) and the Australian Charities and Not-for-profits Commission Act 2012.

The financial statements were approved by the Board of Directors on 20 November 2024.

b. Basis of measurement

The financial report has been prepared on the basis of historical cost.

c. Functional currency

These financial statements are presented in Australian Dollars, which is the Foundation's functional currency.

Foreign currency transactions are translated into the functional currency using the exchange rates at the dates of the transactions. Foreign exchange gains and losses resulting from the settlement of such transactions and from the translation of monetary assets and liabilities denominated in foreign currencies at year end exchange rates are in profit or loss.

d. Use of judgments and estimates

There were no material areas where judgments and estimates were used as the basis for the preparation of accounts.

3. Material Accounting Policies

The principal accounting policies adopted in the preparation of the financial report are set out below. These policies have been consistently applied to all the periods presented.

a. Revenue

Donations

Revenue from donations received from third parties are recognised when they are unconditional, and the Foundation is presently entitled to receive them.

Taxation

Goods and Services Tax

Revenues, expenses and assets are recognised net of the amount of goods and services tax (GST), except where the amount of GST incurred is not recoverable from the Australian Tax Office (ATO). In these circumstances, the GST is recognised as part of the cost of acquisition of the asset or as part of the expense.

Receivables and payables are recognised inclusive of GST. The net amount of GST recoverable from, or payable to the ATO is included as a current asset or liability in the balance sheet.

Cash flows are included in the statement of cash flows on a gross basis. The GST components of cash flows arising from investing and financing activities which are recoverable from or payable to the ATO are classified as operating cash flows.

ii) Income Tax

The Foundation is a charitable institution for the purposes of Australian taxation legislation and is therefore exempt from income tax.

c. Financial Assets

Trade receivables issued are initially recognised when they are originated.

The Foundation initially recognises receivables on the date that they originate. All other financial assets (including assets designated at fair value through profit or loss) are recognised initially on the trade date at which the Foundation becomes a party to the contractual provisions of the instrument.

Material Accounting Policies continued

c. Financial Assets continued

The Foundation initially derecognises a financial asset when the contractual rights to the cash flows from the asset expire, or it transfers the rights to receive the contractual cash flows on the financial asset in a transaction in which substantially all the risks and rewards of ownership of the financial asset are transferred. Any interest in transferred financial assets that is created or retained by the Foundation is recognised as a separate asset or liability.

Financial assets and liabilities are offset and the net amount presented in the statement of financial position when, and only when, the Foundation has a legal right to offset the amounts and intends either to settle on a net basis or to realise the asset and settle the liability simultaneously.

The Foundation has the following non-derivative financial assets: cash and cash equivalents, trade and other receivables and term deposits.

(i) Cash and Cash Equivalents

Cash and cash equivalents comprise of cash balances and call deposits with original maturities of less than 3 months from the acquisition date that are subject to an insignificant risk of changes in their fair value, and are used by the Foundation in the management of its short term commitments.

(ii) Receivables

Trade receivables are initially recognised when they are originated. A trade receivable without a significant financing component is initially measured at the transaction price.

(iii) Other financial assets

Other financial assets consist of term deposits which are subsequently measured at amortised cost using the effective interest method.

d. Trade and other payables

Trade and other payables represent liabilities for goods and services provided to the Foundation prior to the end of the financial year that are unpaid.

e. Employee benefits

(i) Short-term employee benefits

Provision is made for the Foundation's liability for employee benefits arising from services rendered by employees to the end of the reporting period. Employee benefits that are expected to be settled within one year have been measured at the amounts expected to be paid when the liability is settled.

(ii) Long-term employee benefits

The Foundation's net obligation in respect of longterm service benefits is the amount of future benefit that employees have earned in return for their service in the current and prior periods. The obligation is calculated using expected future increases in wage and salary rates including related on-costs and expected settlement dates and is accounted using the rates attached to corporate bonds at the balance sheet date which have maturity dates approximating to the terms of the Company's obligations.

f. Corporate structure

The Foundation is an Australian unlisted public company limited by guarantee.

If the Foundation is wound up or its endorsement as a deductible gift recipient is revoked (whichever occurs first), any surplus assets, after satisfaction of all its debts and liabilities, shall be transferred to another organisation or organisations with similar objectives, which is or are charitable at law and to which income tax deductible gifts can be made. The recipient organisation or organisations must be determined by a Special Resolution of Members passed at a general meeting or in default thereof by such Judge of the Supreme Court of Victoria as may have or acquires jurisdiction in the matter.

The liability of Members of the Foundation is limited. Every Member undertakes to contribute to the assets of the Foundation such amounts as may be required, not exceeding \$20, in the event of the Foundation being wound up while they are a Member or within one year after they cease to be a Member, for the payment of debts and liabilities of the Foundation incurred before the time at which the Member ceased to be a Member and for the costs charged and expenses of winding up and for the adjustment of rights of the contributories among themselves.

There is 1 member of the Foundation as at 30 September 2024 (2023: 1 member).

g. New accounting standards adopted

Material accounting policy information

The Foundation adopted Disclosure of Accounting policy: Tier 2 and Other Australian Accounting Standards (Amendments to AASB 1049, 1054, and 1060) from 1 October 2023. Although the amendments of accounting policies did not result in any change to the accounting policies themselves, they impacted the accounting policy information disclosure in the financial statement.

The amendments require the disclosure of 'material', rather than 'significant', accounting policies. The amendments, also provide guidance on the application of materiality to disclosure of accounting policies, assisting entities to provide useful, entity-specific accounting policy information that users need to understand other information in financial statements.

The Foundation reviewed the accounting policies and made updates to the information disclosed in Note 3 Material Accounting Policies (2023: Significant Accounting Policies) in certain instances in line with amendments.

Insurance Contracts

AASB 17 Insurance Contracts is effective from 1 October 2023. Contracts of the Foundation were assessed against the standard and no contracts determined to meet the definition of insurance contracts under AASB 17.

New accounting standards and interpretations not yet adopted

A number of other new accounting standards are also effective from 1 October 2024 but they do not have a material effect of the Foundation's financial statements."
