

TENNIS AUSTRALIA – 1 POINT SLAM ENTRY TERMS & CONDITIONS

By entering the 1 Point Slam, you agree to the following conditions. Tennis Australia Limited (TA) is happy to answer any questions to have in relation to these conditions.

Background and Governing Rules and Regulations

1. The 1 Point Slam will be conducted by TA in accordance with the official tournament [Rules and Regulations](#), as made available by TA and as may be updated from time to time by TA (acting reasonably).
2. The 1 Point Slam is sanctioned by Tennis Australia and will be run in strict accordance with the Australian Competitive Play Junior Regulations or the Australian Competitive Play Open Regulations, including the [Code of Behaviour: Competitive Play](#), the Disciplinary Policy, Social Media Policy and the Tennis Anti-Corruption Program, which is available at www.tennis.com.au/about-tennis-australia/reports-and-policies/policies.
3. Your participation in the 1 Point Slam is subject to compliance to your ongoing compliance with the rules, regulations and policies listed in paragraphs 1 and 2 above, and it is your responsibility to review these and seek clarification on applicable rules and policies, if you need to. TA is happy to respond to any queries you may have.
4. You agree to always compete at the best of your ability throughout the 1 Point Slam.
5. TA will compensate you by providing you with the opportunity to participate in the 1 Point Slam and to earn prizemoney in the tournament.

Betting Activity

6. In accordance with the Tennis Anti-Corruption Program (www.tennis.com.au/doc/tennis-anti-corruption-program), players and their related persons (any coach, trainer, therapist, physician, management representative, agent, family member, tournament guest, business associate or other affiliate or associate of any player, or any other person who receives accreditation at a tournament):
 - a. MUST NOT wager or attempt to wager on the outcome or any other aspect of the 1 Point Slam.
 - b. MUST NOT solicit or facilitate any other person to wager on the outcome or any other aspect the 1 Point Slam.
 - c. MUST NOT contrive or attempt to contrive the outcome or any other aspect of the 1 Point Slam.
 - d. MUST NOT provide information to others concerning the status of players, or any other aspect of the 1 Point Slam which is not information in the public domain.
 - e. MUST NOT solicit or facilitate any player to not use his or her best efforts in a tennis match in the 1 Point Slam; and
 - f. MUST report:
 - i. any knowledge or suspicion of any inappropriate betting activity; and
 - ii. any approach by any person who offers or provides money, benefit or consideration to event support personnel to either influence the outcome of any aspect of the 1 Point Slam, or provide inside information related to the 1 Point Slam to the Tennis Integrity Unit as soon as possible by contacting integrity@tennis.com.au.

Nothing in this paragraph 6 shall modify or limit the full text of the Tennis Anti-Corruption Program.

Spectator Behaviour

7. You should inform your supporters of TA's expectations regarding spectator behaviour. You are responsible for the conduct of your supporters. Inappropriate spectator behaviour may result in disciplinary action in accordance with the policies listed in item 2 above (including the [Code of Behaviour: Competitive Play](#)). Please note, spectator behaviour includes, but is not limited to, behaviour at tennis venues, event hotels and in transport vehicles.
8. TA and/or the Community Hosts (being TA affiliated clubs, organisations, associations, schools and/or coaches who run events as part of the 1 Point Slam) may refuse you and/or any members of your entourage entry to the tournament or venue if they have reasonable grounds to consider that you or your entourage may present a safety risk to other participants, tournament staff or volunteers.

Entry

9. The eligibility criteria to participate in the 1 Point Slam is set out in the tournament Rules and Regulations (included as an Annexure to these terms and conditions).
10. In the interests of the safety of the 1 Point Slam and other persons at the tournament venues, and the reputation of the tournament, your entry is subject to any additional screening and background check requirements that TA may impose in its discretion (acting reasonably). If TA reasonably considers that your participation in the 1 Point Slam poses a risk to the safety, integrity or reputation of the tournament, or the enjoyment and experience of other persons at the tournament venues, TA may prevent or remove you from participating in the 1 Point Slam.
11. Please note, while TA will not be requiring an entry fee be charged for 1 Point Slam Community Host events, Community Hosts may in their discretion charge an entry fee to help raise funds for their club, business, school or venue. Each Community Host is responsible for collecting any entry fees and TA makes no representation or warranty in relation to the Community Host's collection of any entry fees.
12. Your entry into the 1 Point Slam is subject to you and your accredited guests complying with all relevant federal and state government requirements. TA may also, in its discretion, impose precautionary measures, protocols and other requirements that TA reasonably considers are in the best interests of the health and safety of others, which may change prior to or during the 1 Point Slam. You will be notified of any requirements imposed by TA. Any breach of the protocols, measures and requirements that are in place at the time may lead to serious penalties. TA may withdraw your entry to the 1 Point Slam on the advice of a public health authority or a medical advisor if you have an infectious illness to ensure the safety of others. If you are withdrawn from the 1 Point Slam for any reason, you agree, to the maximum extent permitted by law:
 - a. not to make any claim against or seek any compensation from TA or its employees, officers, directors, volunteers, servants, representatives or agents (TA Personnel) in respect of any expenses incurred or damages, costs or losses suffered by you or any other third party in connection with your withdrawal from the 1 Point Slam, including but not limited to any expenses, damages, costs or losses related to travel, transportation, accommodation, hospitality, prize money, endorsements or sponsorships;
 - b. not to procure, solicit, support or encourage a third party to make any such claim against or seek any such compensation from TA or TA Personnel; and
 - c. agree to hold TA and TA Personnel harmless for any such expenses, damages, costs or losses,
 - d. except where your withdrawal was caused by the gross negligence, wilful misconduct or fraud of

Publicity, Promotions and Use of Image

13. As part of the consideration given by TA to you (including accepting entry into the 1 Point Slam and the opportunity to win prizemoney), and in accordance with [TA's Privacy Statement](#) and [TA's Privacy Policy](#),

you grant to TA, official broadcasters, media partners, sponsors, suppliers and other commercial partners the irrevocable, world-wide, perpetual and royalty-free right and licence to use, reproduce, modify, adapt or publish your name, likeness, biographical details, image (including photographs and audio, video and digital recordings) and voice to:

- a. promote the 1 Point Slam, the Australian Open and TA; and
 - b. broadcast your appearance at the 1 Point Slam, through or in connection with any medium, platform or form of communication, broadcast or transmission including television, internet and mobile telephone (including for providing information and news, archival purposes and promotional purposes).
14. When reasonably requested by TA, you will co-operate with the media and participate in reasonable pre-match interviews, post-match interviews, press conferences, photo shoots, pre-event functions, interviews on-court and finals ceremonies. In doing so, you agree to be respectful of Australian Open sponsors and suppliers and will not publicly endorse or acknowledge any product, service or company. At times your coach may be required to participate in similar activities where reasonably requested by TA, including televised pre-match, during match and post-match interviews and you agree to use reasonable endeavours to ensure that your coach participates as required.

Filming and Photography

15. Other than for your personal purposes only, to protect the rights of our broadcasters as well as the safety and security of the event, you are not allowed to take any photographs, sound recordings, visual footage, audio-visual footage and any other reproductions by any means at the 1 Point Slam ("Recordings"), whether in public or private restricted areas, including without limitation match play, in locker rooms and accreditation-restricted areas (this includes for 'user generated content' posted to social media), without TA's express consent. You agree to use reasonable efforts to ensure that your coach, trainers and other guests abide by this requirement. If you take Recordings without TA's consent:
- a. you assign all present and future copyright and all other intellectual property rights in the Recordings to TA; and
 - b. to the extent the assignment in paragraph (a) is not effective, you grant TA a non-exclusive, perpetual, world-wide, royalty-free, transferable, licence, with a right to sub-license, to use the Recordings for any purpose in any media.

Prohibited Conduct

16. You agree not to engage: in any conduct or do anything:
- a. that will bring, or is likely to bring, TA, a Community Host or the 1 Point Slam into ridicule or disrepute. However, this clause does not prevent you from enforcing your legal rights;
 - b. that will disrupt or interrupt any match or other event or activity during the 1 Point Slam;
 - c. would constitute commercial or political activity.
17. You must not visibly identify or display (without limitation) the name, logo, trade mark, image or likeness of a person or entity sanctioned by the Australian Government on your person, clothing, products or equipment:
- a. on court, before, during and after a match;
 - b. at any press conference or tournament ceremony; or
 - c. in any public area within the Melbourne and Olympic Park precinct.

You further agree to use reasonable efforts to ensure that your coach, trainers and other guests abide by this requirement.

Medical Treatment

18. In consideration of TA accepting your entry into the 1 Point Slam, you:
 - a. consent to TA's doctors and other health service providers (including but not limited to primary health care providers and physiotherapists) consulting with, screening and treating you, and providing emergency assistance or transport; and
 - b. acknowledge and understand that:
 - i. TA and the Event Host are not responsible for medical treatments and only facilitate the services described in this paragraph 18 as they assist participants in the tournament; and
 - ii. there are risks associated with obtaining treatment on-site at the tournament from doctors and other health service providers and you accept those risks voluntarily.
19. You release and discharge, on behalf of yourself and your heirs and legal representatives, TA and the Event Host and their officers, directors, employees and representatives, from any and all claims, demands, suits, damages, costs (including legal costs), loss and injury you may suffer or sustain, by negligence or otherwise, to the fullest extent permitted by law in connection with any medical and health treatments you receive during the tournament.

Medical Records

20. In consideration of TA or the Event Host accepting your entry into an endorsed tournament and providing you with medical and other health services, you:
 - c. consent to Event Host and TA collecting and storing your personal information and records of medical and health consultations or treatment (Medical Records) (including by entering such Medical Records into TA's electronic athlete management system); and
 - d. acknowledge that, subject to Event Host and TA complying with applicable privacy and health records legislation, your Medical Records may be:
 - i. disclosed to doctors, physiotherapists and other relevant health service providers who require access to such information in the course of treating you; and
 - ii. used by TA for the purpose of assessing and improving its programs and events or for research.
21. You may withdraw the consents in this document by notifying TA in writing. If you revoke consent, TA may retain a copy of your Medical Records in its possession immediately prior to the withdrawal of your consent to the extent required to comply with its obligations under applicable legislation including, but not limited to, the Privacy Act 1988 (Cth) and the Health Records Act 2001 (Vic). You should consider the consequences of revoking your consent on your ability to meet your obligations under the Tennis Anti Doping Programme and any other applicable policies. For the avoidance of doubt, any part of the Medical Records which have been de-identified prior to you withdrawing your consent may continue to be retained and used by TA for the purposes of research, or assessing and improving its programs and events, provided that such information is not re-identified

Privacy

22. TA and Community Hosts require the information requested in the tournament registration process to administer its tournament and for related purposes. In this regard, you acknowledge and agree that TA may publish in any media (including print and online) and disclose to any person, your name, age, date of birth, general locality and other relevant information for the purposes of the 1 Point Slam.
23. In addition, you consent to the collection, storage, use and disclosure of your personal information (including via photographic and visual recordings) by TA including for the purposes of tournament

management, tournament safety (including without limitation, COVID-19 contact tracing), research and development, surveys and marketing, including the promotion of the 1 Point Slam and related tournaments, offers from TA and other Australian Tennis Organisations regarding other tournaments, products and services, and offers from third parties who have a relationship with TA or other Australian Tennis Organisations about their tournaments, products and services. The personal information you submit will be collected, stored, used and disclosed in accordance with any privacy statement disclosed to you and the Tennis Privacy Policy (<http://www.tennis.com.au/privacy>), which contains information about how you may access and seek correction of your personal information, how you can complain about a breach of your privacy, and how the complaint will be dealt with. Where personal information is used for marketing purposes, you will have the opportunity to opt out, which you can do at any time in accordance with the Tennis Privacy Policy. TA may from time to time disclose your personal information to third party service providers, for example, IT service providers, in order to provide services to you. Such third parties may be located overseas (as further detailed in TA's Privacy Policy).

24. It is your responsibility to keep your personal details, including contact information, accurate and up to date so TA and the Community Host can most effectively communicate with you and operate the tournament for your benefit.

Risk Warning

25. You acknowledge that in participating in the 1 Point Slam and using the facilities at any tournament venue, accommodation providers and other practice venues, including but not limited to gymnasiums, ice baths, transport services, match and practice courts, you may be exposed to harm or injury. To the fullest extent permitted by law, you acknowledge and accept the risks directly or indirectly associated with participating in the 1 Point Slam and using the facilities at tournament venues, accommodation providers and other practice venues and release and discharge (on behalf of yourself and any associated third parties), TA, TA Personnel, venue owners and Community Hosts from any and all claims, expenses, demands, suits, damages, costs (including legal costs), loss and injury you or any third party may suffer or sustain in connection with, or related to your use of those facilities, except to the extent it was caused by the gross negligence, wilful misconduct or fraud of TA, TA Personnel, relevant venue owners or Community Hosts.

Travel and Accommodation Costs

26. All Participants, except for the 8 State/Territory representatives that win entry into the 1 Point Slam final at Melbourne Park, are responsible for any costs associated in participating in the tournament. This includes flights, car and accommodation expenses if travelling from outside of Melbourne.

Australian Open Accreditation / Ground Passes

27. Participants competing in the 1 Point Slam final at Melbourne Park will be provided with an accreditation pass for the Australian Open to compete on Wednesday 14 January 2025, subject to acceptance and compliance of the Australian Open's accreditation conditions, which will be provided at the time of collection. 2 family members / player support team members will be given ground pass accreditation/tickets to support on the day, subject to compliance with the accreditation conditions and ticketing conditions of entry.

Breach

1. TA may impose a sanction upon any participant who fails to abide by these tournament entry conditions. Such sanction may include but is not limited to, financial penalty, official warnings or full expulsion from the tournament.

Liability

2. To the extent permitted by law, TA, TA Personnel, the venue owners or Community Hosts will not be liable to you for any indirect or consequential loss or damage.

Amendments

3. TA may review and amend these entry conditions where TA reasonably believes the amendments to be in the best interests of the athletes and the tournament. These amendments will be published on the Tennis Australia website at www.tennis.com.au.

I have read, understood and agree to be bound by the tournament entry conditions and freely give the consents set out therein. I warrant that all information provided to TA and the Event Host is true and correct. In participating in the tournament, I consent to being bound by the listed TA policies.

PARENT/GUARDIAN DECLARATION (where participant is under 18)

On behalf of the participant, I have read, understood and agree to be bound by the tournament entry conditions and freely give the consents set out therein. I have explained the tournament to the participant and ensured they also freely consent to the entry conditions. I agree to supervise the participant's behaviour while participating in the Activity and remain ready to respond to the participant's needs.
